BRADLEY BIRKENFELD**

Mr. Birkenfeld was the first international banker to blow the whistle on illegal offshore accounts held in Switzerland by U.S. Citizens. His disclosures have resulted in unprecedented recoveries for the U.S. taxpayers. The recoveries include \$780 million dollars in civil fines and penalties paid

by UBS bank, and over \$5 billion dollars in collections from U.S. taxpayers who had illegally held "undeclared" offshore accounts in Switzerland and other countries.

The Internal Revenue Service acknowledged that information he had provided was so helpful that he received a \$104 million whistle-blower award.

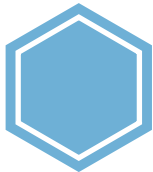
